

HERO IN OUR MIDST: CORPORAL PHILIP COTE, USAAF

Corporal Philip Cote, U.S. Army Air Force—who will celebrate his 96th birthday on October 31—was an eyewitness to history on Tinian Island in the Pacific during World War II. Raised in a log cabin in Tewksbury, Mass., and now living in Dracut, he witnessed two momentous events: two B-29s-the "Enola Gay" and "Bock's Car"—taking off for Japan on top-secret missions.

Philip served as master mechanic and crew chief for the revolutionary Boeing B-29 Superfortresses that first landed on Tinian in January 1945 and, by February 1945, were regularly flying bombing missions over Japan. He was assigned to a specific B-29 and, as crew chief, was responsible for its safe operating condition before it took off for the 10-hour flight over water to the Japanese mainland. He literally memorized the entire service manual to do his job, thanks to his extraordinary memory, knowledge and skill in mechanics, and ingenious mind. (He has eight inventions to his credit.)

Tinian Island is one of the three largest islands in the Marianas—along with Saipan and Guam—and is located 1500 miles south of Tokyo. From December 1944 to September 1945, Tinian played a crucial role in the final months of the war in the Pacific. It was the largest—and the busiest—airbase in the world. It had six 8,500-foot runways built specifically for the B-29s—four at North Field and another two at West Field. The B-29s brought WWII to an end just two-and-one-half months before the planned invasion of the Japanese homeland—an invasion that had cost America 5 million casualties.

Two events stand out in particular for Philip.

In the middle of the night at 2:45 a.m. on August 6, 1945, a huge B-29 Super fortress, the "Enola Gay," piloted by Lt. Col Paul Tibbets, Jr., took off from North Field on Tinian Island. Only hours earlier, the heavy bomber had been towed very slowly over pit No. 1, where a 9,000-lb uranium bomb, "Little Boy," 28-inches diameter and 120 in. long, had been hydraulically lifted into its specially designed bomb bay. Destination: Hiroshima.

It was an incredible sight. Philip remembers the two huge bomb pits that had been dug for the two atomic bombs: one to be loaded into the "Enola Gay"

Last month one of the strongest opponents of Voter ID in the Massachusetts State Legislature, David Torissi (D) North Andover, was defeated by a conservative, Pro Voter-ID opponent named Diana DiZoglio ... who is also ... a Democrat!



- He called people in favor of Voter ID "racist." among other things.

- He ignored the people of North Andover

and supported last year's tax hikes.

Hey Y'All, Guess What?

We are already in chains, thanks to 75 years of "progressive" policies

"He gonna put y'all back in chains."-Vice-President Biden speaking to a largely African-American audience, referring to Governor Mitt Romney

Much has been made of Vice President Biden's gratuitous comment to a crowd in Danville, Virginia, His mimicking of a southern drawl was pathetic and his attempt to exploit racial divisions was despicable – especially given the office he holds. But let's not dwell on these criticisms since they have been already beaten to death by the

Obama-Biden supporters claim that these remarks were taken out of context. Exactly what context would justify them? Putting aside Biden's disingenuous linguistic contortions and deceitful use of the race card, there is no context that justifies an assertion that Romney or the GOP is intent on putting additional chains on anyone.

In short, Biden's statement in Danville was a pathetic, disingenuous, despicable and deceitful packaging of a BIG LIE. The media's attention has been focused on the "pathetic, disingenuous, despicable and deceitful" nature of these comments while ignoring the fact that they were merely window dressing for the BIG LIE.

In truth, the Romney-Ryan ticket is all about reducing the chains that bind us, not adding to them. The only shackles borne by Americans today are those put in place over the years by our government (federal and state). While Republicans have often been complicit in forging these restraints, they have certainly been the more reluctant of the guilty parties. The Progressive wing of the Democrat Party (now, essentially all that is left of the party) has been actively fighting to shackle Americans while destroying our Constitution in the process.

The onerous taxes imposed by all tiers of government diminish our freedoms and drain our economy. Since taxes are the most easily quantifiable burden of big government, it is not surprising that they are the most often discussed.

The taxes we pay fund over 1300 distinct organizations under the direction of 479

departments and agencies in our federal government. As of FY2011, these organizations collectively spend \$3.7 trillion annually with approximately \$2.2 trillion of that from taxes and fees, and \$1.5 trillion (approx. 40%) borrowed.

Yes, paying these taxes hurts. The spending and resultant diversion of productive economic activity hurts. The increased debt adds a fearsome burden onto the shoulders of our children and grandchildren. And the interest on the accumulated debt threatens to swamp any prospect of escaping a downward economic spiral.

What is less commonly quantified and discussed is the impact of the regulations that are a natural byproduct of the growth of government. As everyone knows, the government has a nasty habit of passing new laws and issuing additional regulations that pile up over time and that discourage economic activity and wealth creation. The loss of this wealth reduces our current disposable income and reduces the formation of capital investments that are needed to improve the standard of living of all Americans.

As it turns out, the cost of this accumulated regulatory burden is nearly as great as the burden of all taxes and fees combined.

What is the annual cost of these regulations? In 2008, the estimated cost of complying with federal regulations was \$1.75 trillion (over \$15,000 for every American family). This amount exceeded all corporate pre-tax profits and dwarfed the \$157 billion in income taxes paid by corporations. In fact, it even dwarfed all personal income taxes which peaked in 2007 at \$1.116 trillion (\$1.032 trillion in 2008, \$866 billion in 2009 and \$936 billion in 2010).

In 2010, the federal regulatory burden represented approximately 12% of America's Gross Domestic Product (GDP was \$14.65 trillion in 2010). That means that for every \$8 in economic value created, \$1 was destroyed by the compliance costs of our federal regulatory burden.

It must be noted that these figures substantially underestimate the impact of these regulations. Annual costs are just that: annual. If that wealth were produced, much of it would accumulate each year as savings/investments. Those savings and investments would not only make us more financially secure, they would be reflected in the accumulated capital invested in our industries and research, leading to more efficient production and greater knowledge.

The process of national wealth creation is similar to compound interest in a savings account. Every dollar of wealth that is produced and not consumed can be invested in new factories, capital equipment, research, training, etc., and the proceeds from those investments will compound over time.

It is very likely that poverty, as it is defined today, would have been eradicated long ago if government had not declared war on it, but instead merely created half as many regulations. I often wonder what research this accumulated wealth would have spawned, what new products might have resulted and what diseases might have

If you think about it, the costs expended to comply with regulations and the productive activities avoided because of regulations are two different things. Both cause enormous damage to our economic health. We can only imagine the true cost to our society because entrepreneurs and business-

Scott Brown Says Warren "Desperate"

Vows to continue fighting for Medicare, Social Security and the Economy

United States Senator Scott Brown said his opponent Elizabeth Warren was "desperate" Monday during a visit to the North Andover Senior Center where he spoke for about thirty minutes on Medicare. taxes, the national debt, social security, abortion and the president's failure to sign legislation.

During the question and answer period Brown was asked how he deals with the labeling, stereotyping, personal attacks and hate that gets hurled at him by Democrats during the campaign.

I did it because I was deeply concerned about the approach to handling Medicare reform. In order to do it right, and there is a way to do it, but it needs to be done together, a bipartisan, bicameral way in which the president will sign it."

exploiting the rape of women to get votes, a reference to her most recent radio commercials, Brown said that it was a sign of desperation.

"As the polling is changing more and more in my favor she is getting more and more desperate," Brown said. "People de-



serve better, they do, they deserve better.' Brown said that he didn't pay too much attention to the polls, if he had worried about them when he was down 41 points during the last election "I never would have gotten out of bed."

"But I am doing well in the polls and as

the polls are going up and Professor Warren's are going down there's a sense of desperation, really, if you notice the uptick in personal attacks and the distortion of my record especially... you deserve better."

Third Party Attack Ads

"The one thing I have been thankful for, it was my idea to come up with that third party agreement where it bars all those third party ads. So, you haven't seen all those outside groups coming in and spending tens of millions of dollars and basically cluttering up your TV screens and your radios.

So, we've been talking about our own record and what we plan to do. I was glad that she signed on with me and we have kept them out for six months and that's a good thing. So, the polls are going well I have been up 5, 6% and seem to be on a good swing but you know I'm running like I am down 25 [points]."

Frye Circle in Andover

As a new resident of Frye Circle, in Andover, I was interested in the location and development of such a pleasant setting for a home for senior residents.

The complex contains 96 units. It is named after the Frye family, the first member of the family to make Andover his home in 1646. John Frye came to this area of New England in 1624 and had settled in Newbury. But, soon after he and other settlers sought a charter for this town and so the town of Andover began.

Andover is quite an interesting town to study as the town progressed down through the ages, so did its citizens, establishing and taking part in almost every endeavor of the new country, first as a colony and then as the United States of America.

In fact the northern area of Andover was formerly known as Frye Village. One of John's grandsons, Samuel Frye established a gristmill and sawmill on the banks of the Shawsheen River in 1718. From that era, Andover became one of the most influential mill towns in New England.

A series of articles published by the Andover Townsman and written by

Don Robb, Andover Historical Society have many stories about the town.

But, Frye Circle has a special importance in the town. It was built as a model site for residents of Andover, who needed a home when they became senior citizens and were unable to find suitable housing. Frye Circle was established as a low-income residential housing for the town.

The setting is a large parcel of land, surrounded by woods and stonewalls. It is an ideal location to relax, take walks, and enjoy the wildlife. Yes, wildlife. It is quite a shock to be woken up by a flock of turkeys in the morning. They wander about the complex and sometimes ... into the hallways.

Some of the residents have seen deer, foxes and even a coyote. It is like living in the country, with all the amenities of a New England town. A plus is all the activities that residents can take part in all year. If a resident of Frye Circle needs transportation, a bus is scheduled Monday through Friday, so trips for shopping, library and visits to the Senior Center in Andover can be made. Seniors can enjoy the complex and feel secure that they are cared about at Frye Circle.

Deveau case a travesty of justice

A week ago I almost struck from behind a motorcyclist who had come to a sudden



stop. I was not looking other than straight away on the road, I was not texting, phoning or changing radio station. I was simply

mulling over a work issue in my mind and in a lapse of unknown seconds the traffic condition had changed into a potentially catastrophic one and my reaction to it was misaligned.

That's it. In one blink of an eye quite literally. So what if I was texting? What if I was reaching for a coffee or looking over to my side, or picking up my cell phone. I still get a shiver just thinking about it.

Aaron Deveau is a very decent young man from all accounts. He is touted by Attorney Blodgett for probable political gains later as the "first" texting-driving -negligent conviction. The plea Deveau made that he was negligent in driving but not texting at the point of impact of a terrible accident was swept away. It was not acceptable to the prosecution. Of course not, the drive to make an example with a brand new law superseded any sense of balance and justice.

Donald Bowley from all accounts was a beloved grandfather and friend to all. He did not deserve his life to be short-lived in the prime of it. Luz Roman a vibrant and active woman did not need her happy path in life erased She has lost a dear friend and lives in pain . Her ability to function has made a future impossible to discern. She continues to be a victim and so do Mr. Bowley's family.

Their sentence will never be "suspended"

So what justice exactly was meted that should make the victim's family and Ms. Roman and her family feel that justice was done? Has the public been served by being in a safer state now?

The September 30, 2010 law spells it out clearly: Driving while texting which causes injury is a negligent act which is a punishable crime. To the extent of the law the punishment can earn a distracted-texting driver 2 1/2 years in the House of Correction. So in this case because Judge Abany correctly surmised that he was dealing with essentially a good kid, he creates a confusing sentence that lead Attorney Blodgett to correctly label it as a "no win" situation for everyone.

Deveau was delivered a sentence of 2 1/2 years in the House of Correction on motor vehicular homicide, 2 years for texting and here's where it gets convoluted, 1 year concurrent on both charges with the balance suspended for five years. Only the

15 year license suspension makes sense here.

So with this sentence anyone who asserts that the victim's families have not been served has a valid point. Anyone who feels that Deveau is being victimized for political gain is right too. Remember, these high profile cases often lead to election wins and pay raises later folks, so let's not sweep that under the carpet too.

What should happen here is something a bit more balanced. How about a healthy dose of community service thrown in along with jail time. In addition to suspended portions and loss of license for 15 years, Deveau should serve 2 years but be allowed to furlough frequently with supervision to talk to teens in Massachusetts schools about the consequences of texting and driving and how his life changed "in the blink of an eye". And where would the money come from to do this? By deferring raises to prosecutors who enjoy career

Solomon Decision was Right for Methuen

On Thursday, July 26th, Lawrence Superior Court Judge Robert Cornetta ruled that the City of Methuen had failed to prove its case that the Civil Service Commission erred in ordering the reinstatement of Joe Solomon as Methuen's Police Chief. This was not only the right decision for Solomon, but was the right decision for the City of Methuen as well.Like all of us, the Chief has made some mistakes, but overall Joe Solomon has been an outstanding police chief and has served the City exceptionally well throughout his tenure.

In 2008 Solomon was terminated as Police Chief for alleged mismanagement of Federal grant money and the use of taxpayer money to purchase marine equipment from his relatives. As far as the latter is concerned, this was equipment that the City needed and Chief Solomon actually saved the City money even though at a glance it may have appeared to violate ethics laws. In either case, the Civil Service Commission imposed a one-year suspension on Solomon as Chief in 2009 and ordered his reinstatement as Methuen's Police Chief in 2010. Even though many ethics laws and rulings are well-intentioned, they often lead to negative consequences such as this one.

In praising the Judge's ruling, Chief Solomon's attorney, Andy Gambaccini, stated that the move to terminate Chief Solomon was "poorly conceived, poorly constructed, and poorly executed." I could not agree more! Termination was not necessary.

Upon learning of the ruling, members of the Methuen City Council and current Mayor Steve Zanni announced that they will not likely be seeking an appeal of the Judge's ruling. This too is the right decision. The City has spent tens of thousands of dollars fighting the Civil Service Commission and trying to remove Solomon as Chief. It is time to move on. As City



Councilor Jennifer Kannan observed, "I don't think it's in the best interest of the city" [To appeal the ruling]. City Councilor Mike Condon also remarked, "I don't want to appeal anything. Enough is enough. I want to get this issue behind us. I think the chief is doing a good job."

Currently, the City and Chief Solomon are deadlocked in negotiations over Chief Solomon's federal lawsuit against the former Mayor and the City; and a Superior Court decision in which Solomon was awarded lost wages in the amount of

Chief Solomon has been vindicated and has rightfully prevailed. It is now time for the parties to reach an agreement on these issues and move on in the best interest of Methuen.

On the 29th of April, 2006, Ivan Dragievic, one of the visionaries of Medjugorje, Bosnia, was coming to Abbeylara to share his apparition with the community.

Abbeylara is on the Cavan, Longford border, right up the road from Ballyjamesduff, in the Republic of Ireland.

As I approached the village, I was struck by the way it was so clean, decorated with flowers and banners in Ivan coming. It seemed that every house was cleaned, painted and decorated the same as they did in the old days when the "Station" was celebrated in a special house. Two large marquees were erected on each side of the church. Certainly they were expecting a large gathering.

I arrived two hours before the ceremony and I was lucky enough to get a seat close to the sanctuary where Ivan was going to witness another apparition. He has apparitions every day, and at the same time.

After a half-hour Mass, Ivan approached the alter and knelt down. It was 6:40 PM, There was utter silence in and around the church as Ivan seemed to be in a trance as he looked up into the upper part of the alter. After about ten minutes Iven stood-up and faced the congregation.

Through an interpreter he told us what Our Lady had said to him, and that all her messages were the same, pray, reconciliation, fast, Eucharist and conversion. He continued speaking for about an hour, telling us about his encounter with the Blessed Mother and how he ran and hid in his bedroom, afraid that he might see her again. Now, he was a young lad at that time. He said that while he was in

his room "hiding" from the apparition, he thought, "what if she came in while the door was locked, what would he do?" so, in fear of this, he opted to go to the hill and see her again.

It was raining in Abbylara when Ivan began seeing the apparition in the church. A note was handed to a priest and he gave it to Ivan, the note said, "the sun had come

out and the sun is "dancing". Ivan said the sun always dance's when the Blessed Mother is in our presence.

Sitting in back of me was a young lady, around seventeen years old. She was sitting with parents and siblings. During Ivan's apparition, she slumped over and was "slain in the spirits". Her father picked her up and let her down in the prone position, in the isle where she remained until Ivan was finished "talking" to

Our Lady. When she returned to her seat, I turned and asked her what she saw, her reaction was, "I saw the Blessed Mother in front of me, she was standing on a cloud." There is no doubt that the Blessed Mothers presence was real. The peace and serenity in the little village of Abbylara could be felt.

Now, I first heard of Medjugorje while sitting in the office of a friend of mine in 1992. In came a woman, the late Marie Balter, and she came over to me and handed me medal of the Lady of Medjegorje and said to me, she's calling you. Well I didn't know what she meant by that at that time, but after seeing and hearing Ivan it became known to me that I had to make a journey to the holy village of Medjegorje. I did, two times. Abortion

During the event, Brown was questioned on his stand on abortion and surprised some in the audience. "I am pro-choice and I have been since Gail and I have known each other. There are differences though between Professor Warren and me on that issue. I am not in favor of federal funding. I am not in favor of partial birth abortion. I am not in favor of lowering the age of consent for abortions like she is. And that's a difference. But I believe these issues are best decided between a woman and her doctor."

On the National Debt

"Our country is facing many challenges," Brown said.

"We are facing some real struggles. When I went down [to Washington] there was a 11.95 trillion dollar national debt, it's up to 16 trillion dollars. We are borrowing 40 cents on every dollar.

There's an attack brewing, where they are going to cut ¾ of a trillion dollars of your Medicare. That is something I am not supportive of. I am going to continue to work to protect it [Medicare]. Anyone who is getting it by the way, let's put the mystery to bed right here, anyone who is getting Medicare or will get it, will be grandmothered or grandfathered in. There's no discussion, no effort whatsoever to make sure you don't get those care and coverage, none.

Will my daughter get the same coverage as my mom if we are going to keep the system viable?

Probably not, but that's a conversation we need to have together. It's not going to be a Democrat thing. I know there are some good Democrats here. There are some good Republicans and Independents here, the one thing we have in common folks is we are all Americans first. The only way we are going to solve these national problems is work together. Right now!"

Bi Partisan – The Only Guy

"I am the second most bipartisan senator in the United States Senate. I vote 54% with my party. Every other member of the delegation from Massachusetts votes 96-97% and above. So what does that mean? It means that I am the only guy in the delegation trying to work together to move our country forward.

Brown noted several bills he has worked on with Democrats saying, "As evidenced by my voting record. Insider trading, I didn't know you could go down to Washington and do insider trading and not go to jail.

"But let me tell you something, they will now. I was honored to be in the rose

garden when the President signed that bill to prohibit that kind of thing. I'm hoping

it went a long way to reestablishing some trust between you and us, the people who are working in Washington."

Brown also hailed his work on the "Hire a Hero Veteran Bill." It's now law. The three percent withholding, which is; any contractor that's doing work with the government, that stealth tax that was going into effect, it's gone.

[The] 1099 fix, that affects businesses, that's gone. The Arlington Cemetery Bill, the crowd

funding bill these are all things that I have been working on, [and] trying to save the Post Office, I'm pushing a bill through with Senator Collins, Lieberman, Carper and I, to make sure that the post office will be viable so you can get your mail.

These are the things I am working on each and every day. The things that people care about, right now. Debt, deficit, taxes spending, jobs, national security, and energy, that's what people care about.

They want to know if their sons or daughters, husbands or wives, go off to battle they are going to come home safely. And if they don't come home safely and they comehome hurt, injured, mentally or physically, that they are going to get the care and coverage they need to get better.

I'm on Armed Services, Homeland, Veterans, Small Business [Committees]. I am the ranking member on Armed Services, ranking member on Homeland Security, working very hard to make sure when we send the soldiers out, they are actually able to go out and do their jobs with the tools and resources [they need] to do their jobs well and come home safely.

An Attack on Medicare and Breaking with Paul Ryan

"There is an attack as I said it's an attack on your Medicare.

You know you hear about the Ryan Budget and trying to attack Medicare. I voted against the Ryan budget twice. Twice. And I also put out an op-ed as to why I did it. I did it because I was deeply concerned about the approach to handling Medicare reform. In order to do it right, and there is a way to do it, but it needs to

be done together, a bipartisan, bicameral way in which the President will sign it.

It's not going to be just ramming it through with the scare tactics to scare all of you.

And you are all very intelligent people. You know better. You know you are going to have someone like me down there who is looking out to make sure that you are going to have that contract that was informally signed between the federal government and you, to give you those benefits that are in place. You are not going to be affected at all.

For other generations, in order to make it viable there are going to need to be some changes. I am going to continue to do my best and listen. I don't know it all. I am going to make mistakes. I said that the night I was elected, if you watched my victory speech I said; you know what, I am going to make mistakes and I started right off the bat. I said my daughters are available on national TV. How' that for a pretty good doosie? That being said, I have learned from that mistake and I will continue to learn from that mistake."

Senior Centers

"But I wanted to thank you. I visit senior centers, being on the elder caucus when I was a state rep. and state senator, being a former selectmen, and I am working very hard in Wrentham for our senior center to get that built. Looking at Norfolk and Franklin and visiting the 12 cities and towns in my [former state senate] district is something I enjoy, [like] playing pool, having events, participating in events, it's important. It's a very important part of who I am."

Social security and Taxes

"At the end of this year you are going to wake up on January 1st to a very different country in terms of our tax policy. The child care tax credit is going to be cut down to \$500. You are going to have the lower rates go from 10% to 15%, from 35% to 39.6%. A lot of the tax policy would change dramatically that's the fiscal cliff that even Bill Clinton in a moment

of candor said we can't go close and we can't go over, and I am paraphrasing but I agree with him.

We need to address these issues. I shouldn't be here with you right now. I should be in Washington right now working on these things and I have called for it, I've asked for it, others have as well and some people unfortunately want to go over that fiscal cliff.

I think it sends a very, very bad message to our world partners and others throughout the world who are looking at us as role models, economic role models. Social Security? Listen, it's stable. Does it need to be fixed? Yes. It can be done within the system. I don't think they need to raise taxes on the social security programs like Professor Warren wants to do. She wants to raise the cap and I don't think that's necessary at this point.

Congressman Akin

Asked about Congressman Akin's comments on opposing abortion in cases of rape, Brown said he was the first to ask Akin to apologize and not run. "I was first in the country," He said. "Professor Warren hasn't even asked him to step down and that's putting politics ahead of this every important issue."

Honored to be a United States Senator "And let me tell you something. Besides my marriage to Gail and the birth of my two daughters, being your senator is the greatest honor I've ever had in my life. I mean, to think someone like me, a guy whose mom and dad were married and divorced four times each.

I had lived in 17 houses by the time I was 18, and you have read and heard about some of the abuse and other challenges I have had. But those life experiences I tell you, have made me who I am today. They have given me that foundation, that rock to know what the value of a dollar is. I know what the value of a dollar is. Each and every day I go down there, I read the bills. I understand them and if I don't, I find a way to understand them. I see how those bills affect Massachusetts, how they affect our country, our debt, our deficit, and I vote. That's it. Period ... Period."

Educator Resigns, Moves out of City, Pulls Kids Out of Schools

After a year of demanding public documents and information about how Deval Patrick and his Department of Education is planning to turn around the Lawrence Public Schools with zero results, one member of the Lawrence School Committee has chosen to take her children out of the Lawrence school system and has resigned from the school committee.

Jen Cooper, who was elected over incumbent Mark Gray in 2011 to represent the Mount Vernon "District E" section of Lawrence, says in her resignation letter to Mayor Lantigua that she can no longer allow her children "to NOT be educated in

Cooper, a lifelong Democrat whose party took over the Lawrence Public Schools and stripped the school committee of their power by installing a state appointed receiver says she can no longer trust that the Deval Patrick Administration or Commissioner of Education, Mitchell Chester have the best interest of her children at heart.

Cooper had two small children at the Frost School, Wesley who is seven years old and going into the 2nd grade and Kaitlin who is eight years old and going into the 3rd grade.

"As a parent of two Lawrence Public School students," Cooper writes in her resignation letter, "I no longer trust that my children will receive an adequate education under Receiver Riley's new turnaround plan. As a result, I have chosen to remove my children from the Lawrence Public Schools and have moved out of Lawrence, so that they can attend a school system which will give them the best chance of receiving an excellent education in their formative years."

Cooper says that her decision was not made lightly and cited as one factor, the Department of Education's failure to hire teachers in the classroom who are in the field of education. Cooper says that Receiver Riley and Commissioner Chester are placing teachers in the schools that do not have the experience and are not educators by profession.

"I am a firm believer that every child in public schools should be taught by certified teachers who have dedicated their careers to the teaching profession. Receiver Riley, Governor Deval Patrick and Commissioner Chester do not share that view," Cooper said.

The Valley Patriot obtained an advance copy of the resignation letter which was posted in its' entirety on the web. Cooper says that Receiver Riley and Commis-

sioner Chester continue to spend the tax payers' money in secrecy and refuse to release their spending and curriculum plans to the public.

"Furthermore, their refusal to disseminate information to the public concerning what changes are being made to the curriculum and their insistence on doing the public's business in secret has left me no choice but to remove my children and resign from the Lawrence School Committee."

Under the City Charter a special election must be called to replace Cooper on the School Committee. The Lawrence City Council can obtain a home rule petition from the legislature to forego a special election.

The Lawrence School Committee has not met in more than 60 days and has no authority over spending or curriculum under the takeover legislation passed last year. The legislation does not disband the committee nor does it take away the committee's role as representatives of the voters of Lawrence to question spending of the tax payers' dollars on the Lawrence Public Schools.



Ward 6 Social Club Best (and Safest) Kept Secret in Lawrence

New Owners of Historic Club Restore Image and Neighborhood

The Valley Patriot had the opportunity to sit down with the owners, Tony Fiore and Michael Pelletier, of the newly renovated Ward 6 Club earlier this month. Tony shared the colorful history of this private club which was originally founded in 1931 two years prior to prohibition ending. Mike adds the club was a genuine a speakeasy at one time. The Ward 6 Club is one of the oldest bars still operating in Lawrence. Tony says, "So many people from Lawrence have memories of coming to the club when they were just kids with their fathers and grandfathers." While in the 50's the club was geared to the polish population of the city, today it does not gear itself towards one nationality, but is proud to be

Michael Pelletier, the partner who stumbled upon this opportunity explains the chain of events. "I went into my attorney's office and he had asked me if I wanted to buy a two family. I asked him. 'Where is it?' He said Springfield Street. When he said Springfield I was like ok, am from Spruce street, I can make that work because my background and given I was brought up in the city. I said why not, let's go take a look. When I did, sure enough it was a two family and then he told me about the bar. They didn't want any money for the bar,

but he said 'if you are going to do something with it you need to go and get the license fixed right away.' I brought Tony to take a look at it."

Tony added, "We got wind that the club was for sale and so we came down

came into the space it looked like a dive from the 1970's. It was very old and dated. The ceiling tiles were yellow from smoking and the bar was dark and not very inviting. Mike added that when making the decision to purchase, "We looked at it and got a



and investigated the property. The history behind it was that the club used to be very involved in community and had a large membership. But since there were problems with the neighborhood in the 80's and 90's, business dwindled down. Over the past 4 or 5 years the club was stagnant doing nothing. It had a small aging membership and the club did not have any money invested in it in quite some time. It looked like a dive from the 1970s. In fact when we first

bunch of advice from people. We said that if we are going to do this let's do it right, and that's what we did."

Tony described the undertaking of the huge renovation. "We pieced everything together and family and friends helped us out. We got it going. We just put it together. I got an artist to give me color coordination's on the walls. Basically, we went over the entire space. All the walls have been repainted and re-paneled. The bar top is

all new. We salvage what we could which was 3 or 4 pieces from the original bar. We added new shelves and ceiling tiles, and we went through the bathrooms; everything is all updated now. The main function room has a new floor."

Michael reveals the biggest surprise of the club- the backroom. "You don't know about the backroom until you look into it and it's like an Egyptian tent. You look at the building at front and you just see it as a little hole-in-the-wall two family. When you open the door it's like a huge 'shandrla' type thing. When I went into the back room and saw the oak that had been done, that inspired me to continue the oak to the other side. A little bit of clean up, paint and refurbishing the back hall brought it back to life! We just changed everything."

"We have a new sprinkler system coming up within the next 3- days and we are rehabbing the downstairs now. Downstairs is going to be for dancing and live bands and live entertainment in general. Some of these underground bands are going to be coming in and we hope to mimic the vibe of the middle-eastern restaurant in Cambridge. We want to being in what people want to listen to which could be anything from jazz to Kenny Chesney to country line dancing." Mike and Tony both echo the

Meet Rob Page, an ex-Marine who served from 1990-1994. On June 28th 2012, Rob was arrested, no Miranda rights, no warrant shown and when put in front of the Judge he wasn't allowed due process, the right to representation or a chance to make a case for himself.

He was shackled and not allowed to make any phone calls, for a week he was unable to let anyone know where he was. He was placed in a 24 by 30 foot room with 24 other inmates, some of which were 'dope sick' shaking violently, vomiting, and very loud all hours of the day and night. This room was also on lock down 24 hours a day, so Rob wasn't able to move even to the bathroom without having to walk over people and avoid the issues of vomit, leftover food and detoxing addicts.

Eventually Rob was moved to 'the farm', although it was a short lived stay since his diabetes and blood pressure medicine was kept from him for 5 days and caused adverse effects and he eventually told a nurse about chest pains. He was then shipped back to Middleton for observation and placed into another confined room full of people. Despite being put back in Middleton for observation when he complained about chest pains he was yelled at and told

to wait for other shift workers to come on duty. Well, after waiting 4 hours Rob had to be sent to a hospital because he had a heart attack. He ended up having a stent put in his artery and is lucky to be alive today.

While being imprisoned Rob noticed what others convicted of his vicious crime noticed and that was that they did not get any programs (in fact programs were kept from them), they did not get the same considerations, jobs, resources, or ability to live like the other inmates. What did Rob do that was so horrific that he was denied his Constitutional Rights and treated in a manner that would land people in jail for years on animal cruelty charges? He lost his job. Although Rob was a very successful restaurant owner in Arizona he longed to see his kids like all good fathers and was told that he would be able to see his kids as long as he moved to Massachusetts.

However when he came to Massachusetts, he was only allowed to see his kids for 4 hours over 2 years ago. Judges in Massachusetts don't care. They don't care because men don't have rights unless you have a lot of money to spend on a team of attorneys and then, it only levels the field a little bit. To add injury to all this, the DOR took his license which impacts his ability to get a good job. In fact he landed a

The State House Let Lawrence Down

And the \$34million bandaid the State threw at it fell off fast.

The City of Lawrence has been put in a financial position that is untenable, and

the House Representatives has enabled the city to drift for many years. The Lantigua Administration has been reckless in its financial decisions and it is time to have someone with backbone to stand up for the citizens of Lawrence and take the city back.

Fire Chief Jack Bergeron recently spoke at the Colonial Heights Neighborhood Association and outlined the challenges the Lawrence Fire Department is currently facing. Because of the understaffing of the Massachusetts Firefighters Academy in Stow, the Chief can't get new potential firefighters trained until next April. Two fire stations remain closed, fire apparatus is on its last legs and the stations are in disrepair. The Chief has had to apply for a federal public safety fire grant in order to avoid a layoff of Firefighters.

Police Chief John Romero was excited about the ability to hire a dozen new police officers. However, because the funding source for these officers comes from a federal grant that must be applied for annually, the city potentially must lay off all those officers after just one month of graduating the academy.

At the state level the amount of revenue that has been received by the City of Lawrence in the form of structured local aid has dropped dramatically. Much of the Merrimack Valley has seen these cuts in local aid over the past years, yet the cost of living continues to increase.

How did Lantigua and his accomplices allow this to happen? Why did the City ever get in the position of having to rely on federal funding in order to staff and operate the public safety instead of the general budget of the city? How come one-time funds are continually applied to multi-year needs?

At a local level the budget passed the City Council, but it was definitely not unanimous.

Councilor Marc Laplante voted against the budget because what was presented was not responsible to the safety of the citizens of Lawrence. The Mayor presented a budget that increased people's taxes yet decreased their services. Councilor Laplante was also looking for a budget that added funding for additional police

ADD-ADHD and Other Learning Disabilities

Most people view Attention Deficit Disorder (ADD), Attention Deficit and Hyperactivity Disorder (ADHD), hyperactivity and learning disabilities as behavioral problems or psychological issues. However, these disorders are actually a complex net of neurological, immunological and nutritional problems.

ADD, ADHD, hyperactivity disorders, etc. are just labels, and not good ones. They put expectations on a child that they often will live up or down to. Traditional diagnoses of ADD and ADHD are understandable, but they do not tell us what to do to find the mechanism of the child's "behavioral" problem, in order to balance, improve and or correct it.

The "behavioral problems" stem from neurological and metabolic imbalances. It is not that these are socially dysfunctional children, per se. Their behavior is a result of multiple "functional" imbalances

The latest research is clear on what causes most "behavioral problems" and that is an electrical imbalance between the two sides of the brain. This is called the Functional Disconnection Syndrome (FDS). Here's how it works.

The brain has two completely different sides with completely different functions which need to be coordinated for the whole brain to work in a balanced fashion. These two sides of the brain must fire at an equal frequency for us (humans) to be "normal." If one side fires less than the other (due to trauma,

severe emotional stresses, virus, infections, inflammations, etc.) then that part

brain will express less function and less ability to express itself.

many (not all) behav-

children, the right side of the brain is deficient. The right side of the brain houses our social skills, likes soft music and sounds, houses the stop mechanism of our brain, is the "sad" side of our brain, controls body awareness, concentration and self-control.

The left side of this child's brain likes rote memorization; it's where our "academic" skills reside, likes loud noises, flickering lights (think computer, TV, etc.), likes sameness, or doing things over and over again. This is a very minimal description of the cerebral hemisphere functions but it should serve to educate in this scenario.

Going back to the functional disconnection syndrome, we can see very quickly what happens in the ADD, ADHD, learning and behavioral disabled child. Something occurs to cause the brain to "disconnect" the wiring between

> brain hemispheres and in this example, the right brain becomes weakened and not working very well and the left brain becomes dominant.

This produces a child who likes TV, video games, computers and all things loud (left brain). They interrupt, due to the right-sided weakened social skills. They "perseverate," do the same things over and over again (left brain). They like routines, rituals (left brain). They have a good memory (left brain) usually they have poor social skills (weak right brain), poor body awareness (weak right brain) cannot concentrate (right brain) have tantrums (right brain) and cannot control themselves. This is the ADD, ADHD and frankly OCD, Aspergers and Autistic brain patterns.

This is the hallmark of learning disabilities and "behavioral problems." It is a brain that is functionally disconnected, or out of balance. Coordination and balance are key in functional recovery.

The bottom line remains; one side of the brain becomes very dominant, the other neglected. Over time if the FDS is not corrected, the neglected side (the weak side) almost never gets better on its own. In fact many times it gets worse.

Modern understanding of the neurology of the brain and the metabolic imbalances that trigger and drive imbalances and prevent them from correcting themselves are well understood; as are the specific individualized nondrug methods for their correction. Unfortunately, very few practitioners utilizing the current models of care have ever heard of the syndrome, know how to recognize it or how to treat it successfully. Finding a practitioner with a background in functional neurology and metabolic work is the first step toward a successful recovery.

great job, the company impressed with his work history and talent, however they had to renege on the offer because the DOR had taken his license and it showed up in a back ground check.







Forfeiting Civility in Tewksbury

The 1st in an ongoing series on the Caswell Hotel

Imagine a thief who is able steal without sneaking, in broad daylight. "I need it," he says, and walks off with property that was earned by another, belongs to another. In America, you couldn't get away with that there would be consequences, or at least a halt to the theft, you would think.

But consider the very real case of Russ and Pat Caswell and their family. Over six decades they have built a small business that proudly serves as a motel in Tewksbury. Slowly and carefully, through sweat and smarts, the Caswell's have maintained a motel that has succeeded through the years. They have now hosted some 125,000 rooms over just the past 20 years. No thief should get away with stealing from them, certainly not stealing their whole motel.

Oh but it's happening, in broad daylight, by the very people who are tasked with protecting life and property: the Tewksbury Police, the US Justice Department and the Drug Enforcement Agency. It is a shameful moment for departments with long proud histories. Surely it must be a mistake, you may think. What reason could they possibly give? The law enforcement officers are literally claiming that because some of their residents are criminals, the Caswell's have forfeited the right to their property they earned and maintained over generations.

These customers are individuals. And as any adult is aware, there is a small percent of people who aren't law-abiding. In this case a meager 0.05%, of the Caswell's guests who were arrested over two decades. Throughout this time, the Caswell's have been not only themselves law-abiding, but quite eager, as you'd imagine, to work with local police as they investigate any criminals or possible crimes committed on their premises.

Apparently this is not enough for local government, perhaps especially since the Caswell's have managed to pay off the mortgage, and now own it in full. They've chosen to target a mom-and-pop operation, instead of a big company with lawyers on call. The fact that criminals during some small percentage of time resided on the premises is apparently a great excuse to take the property, by force. It's as if the

motel property itself has been declared

Sure Russ Caswell and others have made numerous 911 calls over the years. But the government is actually using that proper use of government services as evidence against the Caswell's. One supposes they should have never called the officials, had they known they were forfeiting their property rights in doing so. The property, near Main Street, is 4.5 acres, and worth \$1million. The government is actually claiming it's trying to stop criminals by seizing this property of law-abiding Americans. The building and land could be used by the local government, or sold, with proceeds going mainly to the police department. It makes no sense; they claim to be fighting crime while punishing the victims of crime.

Back in 1986, a profit motive was added to America's previously limited civil forfeiture laws. The chance for local police departments to bypass their budgets by this means became huge. Successfully seize and it's yours, with a small portion of the worth going to the federal government. As you may guess, since 1986 civil forfeiture use has blossomed, from \$93 million to a stunning \$1.6 billion. The DEA now has agents who specialize in identifying properties they can seize, giving the appearance of a department focus on acquiring properties of value with ease, over a desire to protect and serve.

The Tewksbury Police and the US Justice Department perform a multitude of essential and even heroic acts. In this story however, the heroes are the upstanding Mr. Caswell and Mrs. Caswell, and the government is playing the role of a miscreant.

The Caswell's, and a group called Institute for Justice, who are working for free on their behalf, deserve our support.

When Russ and Pat head to federal court in Boston on November 5 to defend themselves and the business they built to fund retirement, they also defend the rights each of us possess to the property we have

Please support Mr. Caswell, Mrs. Caswell, and the Institute for Justice, as they try to bring this shameful story to a righteous end.

Anonymous donations open up new possibilities at the Firehouse in Newburyport

Newburyport, MA, - H. Jackson Brown, Jr. once said "Opportunity dances with those already on the dance floor." The Firehouse Center for the Arts has had a pretty impressive dance card the last few years when it comes to theater offerings. Since the Firehouse's inception twenty years ago the mission of the Firehouse has always been to advance the arts and humanities in the Greater Newburyport area. But demands are many and budgets are never quite enough, and so to grow a quality theater program has taken time. In the more recent past, the local arts venue has been making a concerted effort to step up the growth of Firehouse-produced theater and that effort shows in the list of theatrical events on the boards in the Arakelian Theater: Waiting for Godot, House of Gold, Boxed In, The Christina Experiment, Forbidden Newburyport, The Gin Game.

So when an anonymous donor stepped forward last year and expressed a desire to support one specific show, the Firehouse was, needless to say, thrilled at the

vote of confidence. Commenting on how the Firehouse seemed to have put forth a new-found energy and rededicated itself to quality programming, the theater angel decided to make a substantial gift to last year's production of Proof, which was already slated to be in the spring lineup. The play was staged over two weekends last March and received rave reviews on many levels: the directing, the acting, the set design and construction, the lighting. James Atkins has in fact been nominated for an Eastern Massachusetts Association of Community Theaters (EMACT) DASH Award (Distinguished Awards and Special Honors) for the category "Best Lighting Design (Play) for this production.

When the Firehouse produces a show it means that the Firehouse controls the budget. The Firehouse hires the director and then collaborates with that director on choosing the cast. Due to the ever-increasing costs of staging dramatic shows this model has always meant that only minimal sets have been possible for the local theater arts company. Another piece of the

However, it was thanks to this particular donation for Proof that a full boxed set, something usually out of range for the Firehouse, was now possible due to the breathing room provided by the extra funds.

It was the success of Proof that led to the recommitment by the donor – this time to John Patrick Shanley's Doubt, A Parable. Headlining the fall calendar at the Firehouse, the drama will be directed by Suzanne Bryan and will star Caroline Gulde (Somerville) as Sister James, Kathy Isbell (Newburyport) as Sister Aloysius Beauvier, Kathy Ann Hart (Somerville) as Mrs. Muller and Damon Jesperson (Byfield) as Father Flynn. That the donor was willing to repeat their generosity shows that the Firehouse had been a good steward of the funds bestowed them last year. The trust in the Firehouse has not been misplaced.

"To have a moment when the focus is truly on the art and the creative community -- and not solely on the bottom line -- is a real luxury. What we found from Proof, is that the resulting success and energy left everyone bolstered and ready to bring this energy to everything we touch," said Firehouse Development Director Beth Falconer as she expressed her overwhelming thanks for the generous gift.

Indeed the contribution has buoyed the little arts center that could. It is not news that many arts organizations have had to close their doors during the last few years because of difficult economic times. The Firehouse Center for the Arts has, at least for the time being, come through thanks in large part by some serious belt-tightening and the hard work of a very dedicated staff, board and the local creative community. Falconer says "...we struggle to make our beloved arts center affordable and accessible (key to our mission) and financially sound. It's Parents AND (not VS) Teachers

On the news earlier this month, there was a story about a mother who had enough of her teenaged son's behavior. "Nothing worked", she said. He'd been punished by his mother, his school and even the law and, still, his behavior continued to escalate. Mom was at her wits end so she decided to do something some have considered drastic. She resorted to good old fashioned public humiliation. She made a large sign that said, "I lie, I steal, I sell drugs," hung it around her son's neck and made him stand on a busy street corner for two hours. The reaction was mixed. Some cars beeped in agreements, others actually stopped and gave the mother a piece of their mind for humiliating her son. Since then, mom says that her son's behavior has made a major improvement. Way to go mom. It's nice to see a parent parenting and for those who thought it was terrible, what would have been a better solution? Should she have waited until the boy hurt himself or, worse yet, someone else?

As a seasoned teacher of fifteen years I have seen all kinds of parents. Parents are much like the story of the three bears. Some parents are too hot, some are too cold, and others are just right. Sadly, over the years, parents are getting less and less just right and more of them are too cold. In other words, they do not take an active part in their child's life other than buying them the most expensive shoes, clothes and latest electronic devices because that's what they think good parenting is. Their kids don't have to earn it, they just have to ask for it and because many parents don't want to parent, they want to be their children's best friends, they simply plunk down the money and hope that it is appreciated.

Because I am a teacher I am required to jump through hoops to make sure no child is left behind and my school wins the race to the top. I have to speak with students who are underachieving or misbehaving, contact parents and administrators for the same reasons and even counselors if my attempts do not change things. I have

to make sure I have a very lengthy and solid paper trail so that if a student fails or does something that causes damage to school property, themselves, or someone else I and my school will not be held accountable. But, somehow, no matter what proof exists that everything possible was done to help said child, the teacher and/or the school are always held accountable. Where is the student's accountability and, more importantly, the parent's?

Is there anything put in place, by law, that parents have to do and, if they don't, they will be written up, reprimanded, or called out on the carpet? There's the obvious: keep your children fed, clothed and safe. But what about all the other things that is needed to mold a person into a happy, healthy and productive adult? Expensive clothes and electronics is not a part of that equation.

For the most part I usually get positive feedback from parents and students. I have not had a child fail my class in at least half a dozen years and my file is filled with resounding teacher evaluations. But, every once-in-awhile, I do get negative feed back. It's inevitable. With over one hundred students coming through my door every given year, one or two of them won't like me every few years or so. I don't have a problem with this. I didn't become a teacher to be friends with my students. I certainly didn't have children of my own to make new friends for myself.

I am not the perfect parent, but I am proud to say that my daughter is in her third year of college, on the dean's list and a Resident Assistant in her dorm. My son is a United States Airman and my youngest is a senior in high school and may not be the strongest student, but he works hard and is well liked by any one who meets him. I read to my kids religiously when they were growing up, I disciplined them when they misbehaved and I rewarded them with positive love and attention. None of them has ever been suspended or in trouble with the law. I followed through, backed off when they

Forward?

Once again America has been subject to the game of psychological and emotional manipulation called politics. It is offensive to anyone devoted to the truth. In the two national conventions this past month we've learned that Mitt Romney and Barack Obama help their wives with the dishes, love their children, and can cry at puppies being exploited – all in an attempt to get the woman's vote. We heard a number of speakers rip off a line or two in Spanish - for the Hispanic vote, the cameras continuously pan to black and Asian faces to prove the candidates care about minorities, and the constant claim of having trust in "the American people" – a senseless platitude to everyone adding insult to our intelligence.



Finally, it All Makes Sense

I judge a film by how much time I spend thinking about it. A movie that haunts me is "2016: Obama's America," which asks us to consider what America will look like if our president is reelected.

The runaway documentary by directors Dinesh D'Souza's and John Sullivan, attempts to explain the enigma that is President Obama. Relying on years of research, interviews and family records, the film presents a compelling theory that holds-up where previous theories have fallen short.

Frustrated critics of Obama have theorized that he is a socialist, a communist sympathizer, a closet Muslim, or at the very least, completely incompetent to lead the free world. Somehow, none of those labels quite fit. As D'Souza explains, we have been trying to define our President by American history, while ignoring Obama's own history.

Earlier theories have failed to explain why, for example, Obama would do something as bizarre as returning the bust of Winston Churchill, a gift from the British after 9/11. Why on earth would he box up this statue and ship it back to England, insulting our greatest ally?

Why would he not allow the Keystone Pipeline to be completed, creating thousands of American jobs, yet with taxpayer dollars, subsidize and encourage oil exploration indeveloping countries like Mexico, Brazil and Columbia? Clearly, he is not opposed to drilling for oil, just to America doing it.

And why would the President deliberately reduce our nuclear defense capacity while our enemies are eagerly enriching theirs? We got a frightening glimpse into

his motives when he was caught off-mic, at the Nuclear Security Summit, telling Russian President Medvedev, "... After my election I have more flexibility."



es were dissuaded by existing or threatened regulations.

The pure volume of regulations is intimidating. In 2010, federal regulations amounted to 81,405 pages. There were 3,573 new "final rules" in 2010, contained in 24,914 pages of the Federal Register. The Obama administration for the three years of 2009 through 2011 added 10,215 new regulations. Over 38,000 rules were promulgated between 2002 and 2010.

Since the Republicans captured the House in the 2010 elections, the number of new laws has dropped dramatically; but this has not slowed the regulatory bureaucracy. In a trend that should scare all Americans, the growth of regulations has not subsidedjust because Congress is deadlocked. Over the years Congress has ceded substantial authority to unelected bureaucrats. It is the unelected bureaucracy that now passes the

rules largely independent of the Congress we elect.

Today, President Obama rules our lives through the federal bureaucracy and via executive fiat – NOT through the legislative process as was intended by our Founders. EPA regulation of carbon dioxide emissions and ICE declarations regarding immigration are only the most publicly discussed

Regulations are like hidden spending and taxation. Instead of the government spending taxpayer money to achieve some goal, why not just mandate that businesses shoulder the burden? Whether it is job training, health benefits, or sweeping the streets ... just dictate what must be done. The costs will rarely be reported by the media or recognized by the public.

Why don't powerful business interests fight these regulations?

The answer is simple. Small firms (less than 20 employees) spend 36% more per employee (\$10,585/employee) than large businesses (\$7755/employee for firms with more than 500 employees) to comply with federal regulations. Larger businesses often condone new regulation because it gives them a competitive advantage over their smaller but scrappier competitors.

State regulations merely add to the oppressive federal burden.

During the 2009-2011 year period, the state of Washington slapped on over 4000 new permanent regulations. Washington's regulations now take upover 5 feet of shelf space. Would you want to start a business knowing you had to comply with over 100,000 state regulatory requirements? And that is before the Feds even show up!

You probably wouldn't be surprised if I told you that the state of Washington has the nation's second highest failure rate among new businesses. After "poor sales," small business owners list regulatory compliance and red tape as the second most important problem facing them.

The resulting transformation of America - from a mostly free nation where simple common sense dictates if an action is permissible to a nation where hundreds of thousands of pages of impenetrable regulations must be deciphered first – is mindboggling. That the free market has been able to survive this onslaught is even more

destined for Hiroshima, and the other—a 10,000-lb plutonium bomb named "Fat Man," 60-inches diameter—to be loaded into "Bock's Car," destined for Nagasaki. He saw them take off on August 6 and August 9, respectively. In fact, he serviced one of the two bombers that followed the "Enola Gay."

When Philip enlisted in the USAAF in 1942, he had his heart set on becoming an aircraft mechanic. Much to his chagrin, however, he was assigned to serve as a medic in the regular Army. "I couldn't stand the smell of hospitals," he said of his one-year tour of duty in Pensacola, Florida. With dogged determination, he took his appeal all the way to Washington. His persistence paid off, and he was reassigned to the Army Air Force and sent to Tinian.

"The heat was oppressive," he recalls of the broiling semi-tropical sun that beat down on Tinian. "Temperatures climbed well over 100 degrees every day the whole time I was there. And I was there exactly one year to the day. During that time, it rained only one day!"

The ground crews on Tinian were recognized as the hardest workers on the base. "We worked around-the-clock, day and night, to get our B-29s ready for their next mission, sometimes fixing the plane's engine from one raid while preparing it for its next mission. Our only rest came when the aircraft was away on a mission." Philip was responsible for the engines, controls, and accessory systems. At best, he may at times have one assistant and perhaps a mechanic. He could call on specialists from the Service Groups for help whenever needed. Often working 24-hour shifts with little time for meals, Philip dropped in weight from 164 to 124 lb. The sun also turned his skin a deep mahogany color. "It took me two years before I lost my suntan," he smiles.



Philip Cote's indomitable spirit got him into the USAAF as a B-29 master mechanic and during his "three years, one month, and eight days" in the Army Air Force he witnessed the take-off and return of the "Enola Gay" and "Bock's Car" that dropped the atomic bombs on Hiroshima and Nagasaki, respectively.

The Boeing B-29 Superfortress of WWII reached its outstanding combat potential in the Marianas in the Pacific for long-range flights (10 hours to Japan's mainland) over water, flying at altitudes to 34,000 feet.

Innovations included remote-controlled guns, radar, pressurized sections for crew. The B-29s laid mines in rivers, and destroyed Japan's war-making capability. Prince Konoye of the royal family said Japan surrendered due to "the prolonged bombing by the

B-29s." When shooting stopped, B-29s dropped medical supplies, food, clothing to Allied POWS in Japan.

B-29 master mechanic/inventor

As the premier heavy bomber of World War II, the B-29 was developed for longrange, high altitude combat missions. It had a range of over 3,500 miles and flew at altitudes of 27,000 to 34,000 feet. Payload capacity was 20,000 lbs. of bombs.

It featured many "firsts" in American aviation. It was the first bomber to feature pressurized sections (separate sections for flight crew, gunners, and tail gunners).

It was the first to feature remote-controlled guns, the first to use radar units to navigate and locate the target in bad weather. It was the first to use four giant engines (each 2200 hp).

As a result, the crew chief had a heavy responsibility. "We often faced problems never faced before," Philip said. Engines would overheat, catch fire, and cracka tendency made much worse by the 100-plus degree heat on Tinian. Engine overhaul took more than a day to complete. Some engines almost never made it to the 100-hour mark. "We constantly had to change those big engines when they developed problems."

In order to get at the giant engines, Philip had to remove the cowling (outer metal cover) by unscrewing numerous "quarter-turn" fasteners. He found a simpler, faster way to do this by modifying the design of the existing tool then had the machine shop on the base produce it to specifications. When the supervisor saw Philip using the new tool, he took it away. But a few months later, all mechanics on Tinian were using Philip's new tool.

After the war, Philip and his wife Cecile raised their family—Tom (a Vietnam veteran), Carl and Philip Jr. who passed away at 10.

Philip worked for a Lowell textile mill. There he developed an air distribution system to clean textile looms still in use today, although by law his employer holds the patent. Other inventions include: a suction device for a hand-held auto vacuum using compressed air available at any gas station; a zippered vacuum cleaner bag. He even cut a 1939 Buick in

half with a hacksaw, attached a plow to the back and used it to plow his farm.

Doctors call him "amazing"

Philip has escaped many close calls with death. Once while he was working on a B-29, and the co-pilot was sitting in the cockpit, a couple of bombs were accidentally released and rolled out near him. Fortunately, they were not "armed" and did not explode.

The long hours of exposure to the tropical sun on Tinian did wreak havoc. After his discharge from the military, Philip developed melanoma or skin cancer on his arms and back. He's had 41 surgeries to remove these tumors. "Every single doctor told me, 'you are an amazing man to survive all this."

When asked how he managed to over-

come these trials, Philip points heavenward, to the Lord. His long, productive life is a testimony to his faith, work ethic, sense of duty and honor. "I've never sworn in my life," he says proudly.

As the psalmist wrote: "He will call upon Me, and I will answer him; I will be with him in trouble, I will deliver him and honor him. With long life will I satisfy him and show him My salvation" (Psalm 91:15-16).



Single Family Home Sales Up 38% in July

Median Sales Prices Rise Slightly for Both Property Types

The Northeast Association of REAL-TORS® (NEAR) reported today that single family home sales during July in the 15 cities and towns from Boxford to Littleton climbed by 38.3 percent compared with July of last year, while the number of condominiums sold soared by a whopping 60.5 percent during the same period. Year-to-date, sales of both property types were up by more than 20 percent, with a 26.2 percent increase in single family home sales and a 23 percent gain in condominium sales. Compared with June, transactions in July were up for single family homes by 6.2 percent, and condominium sales month-to-month were basically flat -- down by a slight 0.8 percent. The report is based on data from MLS Property Information Network in

The report also reflected increases in the median sales price for both single family homes and condos sold locally during July, compared with July of 2011. Specifically, the median price for single family homes sold in July was \$330,000, a 3.4 percent increase versus last July, but a 5.7 percent drop over June's median price of \$349,950. For condominiums sold in July, the median price of \$197,000 is an increase of 6.5 percent compared with last year and a jump of 14.5 percent versus June's median of \$172,000. The median price is the point at which half the properties sold cost more, and half cost less.

Reacting to the news, NEAR President Mary O'Donoghue said, "The fairly brisk pace of sales this spring and summer has been a welcome change from last year's doldrums. The numbers are definitely supporting, as we are experiencing, a slow and measured housing recovery." She added, "Renewed homebuyer activity has diminished our inventory of homes for sale, so more listings are needed to satisfy the demand. Would-be sellers should be

aware that well-priced homes continue to attract lots of interest and even multiple offers."

The average length of time it took for the single family homes that sold in July to go from listing to closing was 112 days, an increase of 27.3 percent over last July's average of 88 days. It took an average of 122 days for the condominiums sold during July to close, an increase of 14 percent compared with last July.

Additionally, the number of pending sales — those now under agreement but not yet closed — for single family homes in the region during July were up substantially, by 13.7 percent compared with July of 2011, with the agreed-upon median price for those properties at \$329,000, up 9.7 percent versus last July. The number of pending sales for condominiums locally during the month was also up dramatically, rising by 63.6 percent versus last July to 126 contracts signed, with the median

price down by 5.6 percent to \$169,900.

The report also provided inventory levels of area homes for sale as of August 15, which at 1,474 available single family homes and 535 condominiums have each dropped condominiums locally also remains well below the peaks set in 2006 and 2007, which were 2,242 for single family homes and 1,251 for condos.





- 2.5 T oyster sauce
- 1/3 c vegetable or chicken stock
- 4 T soy sauce
- 2 T + 1 t sake or rice wine vinegar
- 1 T chili paste
- 2 T corn starch
- 2 T water
- 1 T peanut oil
- 3 T pressed garlic 1 T granulated sugar

To start, prepare sauce until point of cooking it. Reserve until rice is done as



the sauce thickens very quickly. For garlic sauce:

In a small bowl, stir together oyster

sauce, stock, soy sauce, rice vinegar, & chili paste. In another small bowl, dissolve cornstarch in the water.

Heat oil in a saucepan on mediumheat. Add the garlic & stir briefly until

Turn the heat to medium low. Re-stir the sauce & add it into the saucepan. Stir in sugar. Bring sauce to a boil, stirring.

Re-stir the cornstarch & water mixture. Add into the saucepan, & stir quickly until sauce has thickened.

Note: Adjust the heat up or down as needed to bring the sauce to a boil or keep it from cooking too quickly.

For rice:

Heat a Dutch oven over medium high heat & add 3 T oil & then onions. Cook onions until translucent. Add rice & cook, stirring, until rice is translucent. Add two cups of stock, stirring constantly until rice has absorbed almost all of the stock. Keep adding stock one cup at a time until the rice is cooked.

Heat a small frying pan on medium high heat & add 1 T oil& the carrots. Cook, stirring occasionally, until carrots are almost fully cooked. Remove from heat & reserve.

When the 2nd to last cup of stock is added to the rice, add carrots & peppers. When last cup of stock is added, add the zucchini & mushrooms. Stir until nice & creamy.

Add the reserved garlic sauce & serve.

What I did discover is that one can add shrimp, tofu, or

any other meat that is fully cooked at the end. The shrimp, if small ones are used, can be added along with the last vegetables & they will cook in no time as will the tofu.

Serves 6-8 as main course or 8-10 as

My second dish is something that I love to make for breakfast. Yes, I'm still at breakfast from last month! It's Dutch apple pancakes! Perfect going into apple season.

1.5 c flour

3/4 c ground flax seed meal

1.5 c milk

½ c old fashioned oatmeal

½ t salt

2 room temperature eggs, separated

4 T sugar

1 T + 1 t baking powder

1 medium crisp, firm apple, cored &

sliced (with or without peel) (for each frying pan)

2-3 T brown sugar (for each frying pan)

> 1 T butter (for each frying pan)

> > In a medium mixing bowl add dry ingredients, egg yolks, & milk. Mix well.

In a separate bowl, beat egg whites until stiff peaks form.

Fold egg whites into mixture. In a small frying pan, heat butter over medium heat until melted.

Pour in batter& turn

temperature to medium low.

Cover entire top of pancake with apples in a pretty fan pattern.

Top with sprinkled brown sugar. Place a lid over pan & steam over medium low heat until done.

This takes approximately 5-7 minutes. Serves 2 per frying pan. Total number of servings: 8

NOTE: Any leftover batter will become very stiff & glutinous. There is no need to thin out batter unless it becomes so glutinous that it is unmanageable. When batter is placed in pan, just spread it out & proceed as usual.

MOODY'S GIVES HAVERHILL FI-NANCES A VOTE OF CONFIDENCE September 4, 2012

Mayor James J. Fiorentini today announced that Moody's Investment services, which rates Haverhill's municipal bonds, has improved their outlook for the city and removed a "negative outlook" placed on the city several years ago. Moody's kept Haverhill's bond rating at A1, its highest rating since the start of the Hale debt twelve years ago.

Haverhill's finances and municipal bonds are rated by two Wall Street firms, Moody's and Standard and Poor's. Moody's both gives a rating and a bond "outlook" that is a predictor of how they feel that the city finances will do in the future. A few years ago, Moody's outlook for the city was negative, and at that time Moody's pointed to unsigned union contracts and the lack of adequate reserves. The latest bond rating removes the negative outlook and upgrades the city's outlook to stable.

In this year's budget, the city made it a point to add \$1.2 million to its reserves, boosting reserves their highest level in many years. At the time, Mayor James J. Fiorentini said that one reason for adding to the reserves was protect the city's bond

In upgrading the city, Moody's specifi-

cally credited the city with settling the collecting bargaining agreements and the city's focus on improving its financial reserves. Moody's rating said:

"Removal of the negative outlook is based on Moody's expectation that the city's financial position will stabilize as a result of recently settled collective bargaining agreements and an overall improved economic environments and focus on improving reserve levels."

In making the announcement, Mayor Fiorentini said that the new outlook reflected a confidence by Wall Street rating agencies in the direction that the city has been taking, and was a vote of confidence in the budget priority of adding to re-

"In the most recent budget, we strongly resisted the urge to spend every dollar that came in. Instead, the city concentrated on building its reserves and planning for the future. We saved money this year because of our hard choices in having a new health care plan which saved us \$1.1 million, and we were fortunate to have had a warm winter and State money to help with the Hale debt. There is always pressure to spend everything that comes in, but we resisted that pressure. We did not add significantly to our workforce, kept overtime in check and added to our reserves.

"Now a major Wall Street firm, Moody's, has given our focus a vote of confidence. Keeping a stable financial rating and stable bond rating is a major goal of this administration. It is gratifying to have a bond rating agency recognize that the direction we are heading is the right direction."

SALISBURY MAN JOINS NECC **TRUSTEES**

Ronald J. Guilmette of Salisbury was recently elected to the Northern Essex Community College Board of Trustees by alumni. Guilmette, a retired Lt. He currently teaches criminal justice at UMass Lowell and Merrimack College.

"It is exciting for us to have a prominent alumnus join the trustees," says NECC President Lane Glenn. "He will offer a unique perspective."

The college's Board of Trustees includes nine members who are appointed by the governor of the state to a maximum of two five-year terms as well as an alumni-elected member, who also serves a maximum of 10 years, and a student trustee who serves for two semesters.

Lakeview House Skilled Nursing and Residential Care Facility, founded during the mid-1940s, provides 26 licensed skilled care beds and 65 residential care
